From the author

Why is humanity ignorant of the essence of what is happening, despite the competence of many people in certain fields of knowledge? Because without a deep, full-fledged knowledge of macroeconomics (political economy), it is impossible to understand the logic of ongoing events and existential threats.

By full-fledged knowledge, I mean knowledge of the law of change of socio-economic formations, known as **the law of conformity of the development of productive forces to the nature and level of production relations**. According to this law, in case of **nonconformity**, the functioning of the socio-economic formation becomes impossible. Today we are witnessing a growing **nonconformity**. The increasing automation and robotization of productive forces deprives a person from production (socio) relations. The understanding of fact that the capitalism is doomed is the reason for the reactionary actions of the parasitic, super-rich global elite, who today are ready to commit any crime against humanity in order to maintain their dominance.

By full-fledged knowledge, I also mean *knowledge of the method of social production of the future*. Specifically, knowledge of «**A FAIR METHOD OF SOCIAL PRODUCTION**», the macroeconomic formula of which I derive in 1987, having discovered **the dual nature of competition**. In 1996, my monograph «**A FAIR METHOD OF SOCIAL PRODUCTION**» was published in the scientific and theoretical journal "Communist Herald" 2'96, Publishing House, Krivoy Rog-2, Ukraine. If, under capitalism, political superstructures are needed to retain by a super-rich minority, to create the illusion of democracy and the appearance of government concern for the people, when **FAIR METHOD OF SOCIAL PRODUCTIN** (thanks to built-in algorithms) can as efficiently as possible, meet the needs of the population, without any political add-ons.

Today, everyone is hypnotized by artificial intelligence as the ultimate good. But it should be understood that in the hands of the globalists, the super-rich elite, AI is a goat provocateur, whose main mission is to lead humanity into slavery and slaughterhouse. The International Doctrine of Absolute Democracy will point the way to the future, to the golden age of humanity. Would you like to?

EVERYONE SHOULD KNOW THIS

"Look at the root" (Kozma Prutkov)

Why is this Teaching/Doctrine the main book of mankind?

Because it points to the most important problem of humanity and gives it's the right solution. What is the main problem? The problem is that **no nation today controls that is happening in their country**, which means they **do not control their future**.

What is happening in every country today is controlled by its oligarchic elite, through its appointed presidents and prime ministers. If presidents or prime ministers start acting on their own-acting not in the interests of the oligarchic minority, then they are impeached or physically eliminated. In turn, the national oligarchic elites are directly depend on the global super-rich elite, which determines the architecture of the future for all mankind based on personal parasitic interests.

So today, according to the plan of the world's super-rich elite (plan which was developed by the Club of Rome, created by Rockefeller in 1962), on planet earth, a new world order is being established – a digital fascist concentration camp for humanity. What is its essence? The essence of the digital world order is to establish total control over every inhabitant of the planet by replacing existing money with digital ones. The consumption of which will be strictly limited (for example, 500 for gasoline, 700 for food, 300 for clothes, etc.), depending on the social rating – points scored and loyalty to the policy pursued by the regime (for example, you haven't been vaccinated and your account is blocked). Payment with digital money will be made through biometrics (payment with a smile) or through a special messenger in the phone (in Russia, the Max messenger has already been launched for this), which will contain all available information about the owner, including his digital account.

What needs to be done to ensure that everything that happens in each country is controlled by its people? There's only one way out - to establish ABSOLUTE DEMOCRACY. Because, **the power of the people is control**. Control over what is happening, control over the executors – servants of the people, control over the fulfillment of the will of the people. **Is it difficult for the population to control what is happening?**

It's not difficult to understand that you're living worse than you did yesterday, just it is easy to ask responsible officials if there is a **mechanism of public supervision**, which is described in this doctrine. What do we have today? Instead of living better every day, the world's population is living worse and worse. There are more and more wars. This is all the result of the power/rule of a self-serving minority – a fake democracy, where the population, fooled by the media and flawed education, in fact plays only the role of extras, which has no real leverage over the president «elected by the people», even in the case of desperate with his actions.

Today, the vast majority of the population does not know **the root cause** of the horror that is happening on our planet today. Therefore, they do not see the real picture of the world and **the prospect of depriving humanity of the future**.

In order for the root cause and picture of the world to become clear to everyone, I will give a maximally simplified, illustrative example of what is happening:

Imagine that the world (our civilization) is **a galley**, and people (all working) - **rowers**.

The galley has **owners**, these are 300-400 super-rich families.

Due to technical progress, they began to install a motor on the galley (automation, robotics + AI).

The owners of the galley had a problem: Where to put the rowers? They need to be fed, clothed and guarded so that they do not rebel and declare their right to own the galley.

By putting this requirement, the main desire of the super-rich to rule forever is at risk.

Therefore, the galley owners decide to quietly dispose of the rowers (through biological weapons – artificial pandemics and vaccinations, through climate weapons that will cause crop failures - famine, through GMOs, chemtrails, medicine optimization, hot wars, etc.).

With the expectation that no more than 10% of the rowers, survivors remain for service (already with electronic shackles, in the form of digital money).

What should the rowers do? Establish their power on the galley and not let themselves be disposed of? But according to the lying propaganda (paid for by galley's owners), there is already a rowero/cracy (democracy) on the galley.

Consisting of the right of rowers to elect their captain. The misled rowers do not realize the elementary, namely, that the right to delegate power over themselves is not the acquisition of power:

"THE RIGHT OF COWS TO CHOOSE A SHEPHERD DOES NOT MEAN THE TRANSITION OF POWER TO THE COWS."

From the point of view of macroeconomics (political economy), the above - given example illustrates the action of the law: **Conformity of the development of productive forces to the nature and level of production relations**.

The reason for the **nonconformity** (which makes it impossible for the social formation to continue functioning) is technical progress.

Thus, as a result of technical progress, the slave system was replaced by the feudal system, which, for the same reason, gave way to the capitalist system. And today we are approaching the point when capitalism will no longer correspond to the current level of development of productive forces. Therefore, it will be forced to give way to the next (**according to evolution**) fair socio-economic system. But the super-rich elite, owning huge assets and considering the planet its property, is openly against (as in the above example with the galley).

Possessing unlimited financial resources - being the Masters of money, the super-rich elite, today is turning our civilization back - back to the past. Into a neo-feudal system - a new world fascist order, the digital concentration camp under supervision of AI (digital government). Why do they manage to do this? Because under capitalism, without money, nothing can be done, but with money, it is possible to do everything. Even strangle humanity, with its own hands (for 30 pieces of silver).

"A SOCIETY WHERE MONEY IS VALUED HIGHER THAN JUSTICE, HIGHER THAN MORAL VALUES, IS A BITCH SOCIETY. BITCH, BECAUSE IN SUCH A SOCIETY, HUMANITY WILL, FOR MONEY, BUILD ITSELF, DRIVE ITSELF INTO CONCENTRATION CAMPS AND GHETTOS, AND FINALLY LIQUIDATE IT."

What conclusions should be draw from all has been said?

The first conclusion: if you are not part of the elite of the super-rich, then the establishment of a new world order is categorically not in your interests. Because the fate of a powerless slave - a service person (of any level), who, at any moment (for reasons of profitability), can be erased from the book of the living, is not the best prospect.

The second conclusion: if the main goal of the super-rich world elite is the disposal of the planet's population, then the chemical composition of chemtrails and vaccines definitely contain carcinogens or other substances that bring us closer to the next world + components that cause infertility. For example, the vaccination of girls in Kazakhstan against candelabra + the joyful statement of Ursula von der Leyen that she, together with Bill Gates, is going to carry out mass vaccination of young children, does it not raise specific suspicions? Today, the political systems of all states have proven their democratic failure. Because they do not allow the population to really control either the composition of vaccines (which is declared a commercial secret), or the composition of chemtrails and the possibility of banning them, or declaring wars, etc.

The third conclusion: you should never trust those who work for your enemy, that is, for the world's super-rich elite. This is, first of all, the media and the entire bureaucratic vertical of power, headed by the presidents, of almost all the leading countries of the planet.

The fourth conclusion: "NEVER DRAW CONCLUSIONS WITHOUT UNDERSTANDING THE ESSENCE." What is the power of the essence? The power of the essence is that it makes anything complex simple and understandable. Today, when all means of information influence are aimed at fooling the population (by substituting concepts and deliberate lies from corrupt "scientists"), everyone, in order to correctly navigate what is happening in their country and the world, needs to know **the main geopolitical truth - the essence**. What is it?

The essence is that there are only **two types of power** (despite the seeming diversity of forms): **the power of the minority** and **the power of the majority**.

The truth is that power should only be in the hands of the majority – the people.

"WHO HAS POWER, HE HAS HAPPINESS"

If power is in the hands of a minority, then everything will be done in the interests of this minority. The final point of minority power is the establishment of a new world fascist neo-feudal order - a digital concentration camp. And this is not a conspiracy theory, this is what the world "elite" is doing today a tiny, super-rich minority.

If power is in the hands of the majority (ALL - the people), then everything will be done in the interests of all.

The final is the golden age of mankind.

WHAT IS POWER, IN PRINCIPLE?

Power is **goal-setting** (dictatorship of the holder of power) and **control** (supervision of the holder of power over the execution of the dictate).

WHAT IS THE POWER OF THE MAJORITY?

The power of the majority is not declarative statements about the power of the people. The power of the majority is when the majority - the people make (approve, as the Master of the country) strategic decisions and the people themselves, control - supervise their implementation. The power of the majority is Absolute People's Power, the mechanism of which is described in this international Teaching. *WHO CONTROLS WHAT IS HAPPENING CONTROLS THE FUTURE* **Control is the main component of power.** Because if there is no control over the executor or the implementation of the goal-setting (will), then there is no power. Because without control, any order can be ignored or not executed properly.

On planet Earth, everything directly depends on the control/supervision factor:

"ARE WE CONTROLLED OR ARE THEY CONTROLLING US".

If WE are controlled (the people, humanity), then we are slaves.

If WE control (our servants - governments and officials), then WE are the Masters of our countries and the planet - the Masters of our future. **TODAY, WE ARE CONTROLLED BY THE MINORITY AND THIS IS UNACCEPTABLE.**

HOW THE MAJORITY CAN RULE?

Majority can rule in only one way - by establishing goals (imperatives) through the vote of all in a national referendum, with subsequent control, by all, over the proper implementation of the adopted goals - the will of the people.

A historical example of the power of the majority - the people, is the Novgorod and Pskov Veche (People's Assembly/ Referendum in 1136 – 1478 year). Also, in the Middle Ages, the power of ALL - the majority was among the Scandinavian and Germanic peoples. The People's Assembly - Ting (Tang), where strategic decisions were made by all the peoples, and secondary working decisions were made by the top appointed by the people.

The modern version of the power of the majority is **Absolute Democracy - Absolute People's Power**. What unites the medieval version of People's Power with the modern one? That in both versions, the Supreme Authority (both in the country and in the medieval republic) is the Referendum - Assembly. How does modern People's Power differ from its medieval prototype? That modern People's Power is Absolute. Its absolutism consists in the fact that the people do not delegate to anyone the right to govern themselves. That is, the people do not look for good kings presidents/prime ministers and honest deputies/parliamentarians, but themselves, through referendums/assemblies, approve goals (tasks for the servants of the people), and themselves, through their (alternately changing) Duty Representatives from the population, control the execution of their will, and also supervise the activities of territorial administrations (at all levels), and everything that happens, in general. Supervises from the position of protecting the interests of the people of all and preventing the seizure of power - appropriation by anyone, of the right to decide for the people. For this reason, Absolute Democracy is an order of magnitude more effective than all its prototypes.

For those who doubt the ability of the people to rule approve/make decisions, I will briefly formulate the algorithm of the functioning of Absolute Democracy:

The first function of Absolute Democracy is the population's supervision of the executives - servants of the people, in order to prevent, deterioration of the quality of life of the population;

The second function of Absolute Democracy is the goal-setting of the population, executive structures - servants of the people, with the aim of improving the quality of life of the population, according to the principle: **FROM THE ACHIEVED, TO THE BETTER**.

As you understand, the above algorithm, already automatically sets a progressive vector for the development of society.

If Absolute Democracy provides political power to the people, then the **"FAIR METHOD OF SOCIAL PRODUCTION"** (which is also given in this Teaching) provides the people, economic power - high-quality satisfaction of their needs.

"FAIR METHOD OF SOCIAL PRODUCTION" is a method of production of the socio-economic formation following capitalism - is a method of production, the formation of the future.

Of course, if the population of the planet manages to get rid of the syndrome of learned helplessness (the helplessness of individuals-divided), they will unite and establish Absolute People's Power (Absolute Democracy) in their countries. Realizing that there is only one road to the future for everyone.

Since the reason for today's reaction of the super-rich elite - the trillionaires' club, is precisely that capitalism is doomed.

Because when machines start producing everything, people will become unemployed, and therefore insolvent. The capitalists will have no one to sell their goods/products to, and capitalism will collapse.

The super-rich world elite does not want to move to the next fair socio-economic formation. Since in a fair formation it will have to say goodbye to its dominant position as the Masters of planet Earth. For this reason, since the fall of 2019, the super-rich world elite has begun an all-out hybrid war against humanity, pursuing two goals.

Where the first goal is to establish a new fascist world order, which will ensure eternal domination for the elite.

The second goal is a multiple reduction in the population of the planet, as superfluous for the planned million masters.

If in the 20th century, all material goods were created by human hands, then in the 21st century, robots can and have already successfully replaced humans almost everywhere. If huge production capacities and energy resources are needed to meet the needs of 8 billion people on the planet, then for 1 million masters of the new world order, together with slaves-servants, many times less industrial capacities and resources will be required.

Today, an arguably mega critical moment has come in the existence of human civilization. The secret world government (the world behind the scenes) has not only shown its ears, it has shown its fascist grin by setting up Auschwitz 2 on planet Earth, ordering presidents and governments of countries to inject the population with experimental vaccines. To poison with chemtrails and use climate weapons against humanity to cause crop failures and, as a consequence, famine.

As a fact, it can be stated that presidents and prime ministers at the present moment do not serve their people, but carry out orders from the super-rich world elite to build a new world order, with a digital concentration camp for the population. Using all the achievements of the so-called 4th industrial revolution, to enslave peoples and turn everyone (who is not utilized) into service people (vegetables), for 1 million masters, a new world order.

Today, Schwab is advertising - launching a new fool for the people, which should replace the existing democracy. A fool, called Algocracy (i.e. the supreme power of algorithms over people), which will completely deprive a person of the need to use his own brain. Since it will tell him absolutely everything - how best to act, in all cases, even in private life. As a result, this will lead to a deep degradation of mental abilities. Is it reasonable for people to turn into blockheads, led by AI algorithms?

Why are they not engaged in the economy and the production sector, to improve the quality of life of people, which is deteriorating year after year, but are directly engaged in people? The answer lies on the surface: "Their problem is people, not the problems of people."

As is known: **"Being determines consciousness."** Consciousness, formed by capitalist being, today works against people. Why?

Firstly, because it divides people, i.e. it works for the formula of minority power: **"Divide and rule"**. Today, everyone is for themselves and their wallet/capital, and is hungry for money, which, after the establishment of a new world order, having become digital, will turn into dust - deprive a person of any sovereignty.

Secondly, because today, 99% of the population is convinced that the right thing is to engage in making money and not engage in politics (i.e., according to Aristotle's definition - to be idiots).

Therefore, having sat down, like drug addicts, to earn money, people do not notice what is happening and do not see the trends. In other words, people were deceived - deceived, having set before them a false goal - the fight for money, and not for the power of the majority.

In addition, the super-rich know that they can always ruin or bring to their knees, the less rich.

In 1996, in my monograph **"A FAIR METHOD OF SOCIAL PRODUCTION"** i warned that when capitalism begins to collapse, the super-rich, in order to preserve their dominance, will go to the destruction of humanity. And so it happened. Therefore, the pandemic, artificially arranged by the globalists in 2019, for me was a theoretically expected and understandable event. Equally understandable, as were the extremely criminal goals of those who organized it.

Yesterday, driven by self-interest, they infected the Indians with smallpox (by distributing blankets). Today, the world elite, driven by self-interest, has begun a hybrid war against all of humanity, with the goal of bringing down (using similar methods) most of it. Evil must be stopped or it will stop us - destroy us.

Every adequately thinking person, having grasped the essence of the above, will make an unambiguous conclusion that each nation urgently needs to establish the POWER OF ALL - Absolute People's Power in their country, in order to take control of everything that happens in it. Since leaving power in the hands of a minority today is equivalent to suicide.

"TODAY, THE PEOPLE WHO DO NOT CONTROL WHAT IS HAPPENING IN THEIR COUNTRY ARE DOOMED TO SLAVERY AND DISPOSAL"

CHAPTER 1

ABSOLUTE PEOPLE'S POWER AS THE ONLY WAY TO SAVE HUMANITY

Today, all existing political systems and regimes have proven their inability to protect the interests of their peoples. On the contrary, judging by their deeds, we see that all of them, without exception, are focused on serving the interests of the minority - the interests of the super-rich ruling elite. Why? Because:

"Under capitalism, whoever has economic power has political power" (this is dialectics). Political power and economic power do not exist separately - they always have one Master.

The main function of political power is to protect/guard the economic interests of the Master. Under capitalism, the Master of the country is the elite - the minority that owns capital. Therefore, under capitalism, the people cannot have political power, a priori.

In fact, all democracies today are 100% a scam of the population due to the insignificance of feedback. For example, the president broke his election promises. What can the people do? Organize a rally? But the police and the army are always subordinate to the president (prime minister). Therefore, he will disperse any protest.

What is ABSOLUTE PEOPLE'S POWER – ABSOLUTE DEMOCRACY?

There is such a thing as absolute monarchy, when all power is concentrated in the hands of the monarch. I am introducing a new concept/term Absolute People's Power, which means that the Supreme power in the state is always and invariably in the hands of the people. That is, the people do not transfer - do not delegate the Supreme power in the state to anyone. He himself approves the goals at referendums/meetings and controls the implementation himself, through **the Duty Representatives of the population**. Who will, like the prosecutor's office, supervise everything that happens, at all territorial administrative levels, standing guard over the interests of the population.

Absolute People's Rule is the POWER OF ALL. Because when making decisions, everyone votes and everyone controls the implementation.

Why is the power of the majority the power of the people?

Because the people can make decisions in only one way, by **voting**, and, as is known, the decision for which the majority votes is made.

The concept of Absolute People's Rule - the POWER OF ALL, is simple. The head of the state should be not the president, not the parliament, but a **PERMANENTLY OPERATING NATIONAL REFERENDUM – ASSEMBLY OF CITIZENS OF THE COUNTRY** (the institution of goal-setting of the population), through which the people will declare their will. The will of the Master of the country.

It should be understood that the people will not engage in manual control. The population will give tasks and appoint managers (top managers) and heads of territorial administrations.

For example, the chairman/prime minister of the government and if he does not cope with his duties, and the people do not see an improvement in the quality of their life, then the population will appoint another. It is also necessary to note that the intellectual storming of problems will be carried out by organizations and individuals with the appropriate competence.

The population, as the Master of the country, its region, its city, will approve the most convincing option/project.

In the described situation, of course, there can be no corruption, since the people will control everything. The dialectic of control is simple:

"THE MORE CONTROLLERS, THE BETTER THE CONTROL WILL BE"

For a clearer understanding of the principle of functioning of the Absolute People's Power, I will give a simplified, illustrative example, with a conditional bus.

Where the bus is the state, the population are the passengers, the head of government is the driver. The bus is the common property of all passengers (the population). Passengers (the population) vote on where, at what speed and with what stops to go, and the result of the vote - a waybill is handed over to the driver (the head of government). For (constant) control, a duty officer is placed over the driver, so that he does not violate the order (waybill) issued to him.

For this, a rotating duty is established among the passengers (so that the passenger on duty controls the driver, and the rest can enjoy the ride). The duty officer's status is higher than the driver's status and if the duty officer sees that the driver has violated the order issued to him, he has the right-obligation to order the driver to stop, but no more. Then, inform all passengers so that they can make a decision on the driver, since making decisions (personnel and strategic) is the prerogative of passengers (the population).

Are engaged in It should also be taken into account that passengers (the population), when choosing a route, do not engage in collective intellectual storming.

Passengers organize a competition for authors of projects - tour guides. They invite experts and after debates, they approve, by means of voting, the route they like.

The opposite example is an example of minority power, when the driver (the super-rich elite) is the owner of a conditional bus.

Then the driver/owner, realizing that passengers will soon be unable to pay their fares (since they will become unemployed) and that they cannot be easily kicked off the bus, having isolated themselves in the cabin, begins to add chemtrails to the air conditioner. He begins to periodically throw a virus-infected rag into the passenger compartment, and to ensure that his goal is achieved, he obliges everyone to be vaccinated with extremely harmful vaccines. Those who refuse the procedure, the driver begins to kick off the bus, shouting into the microphone about the terrible infection, which came from nowhere, which will definitely not go away, and about the carbon footprint of the bus, which is reduced when passengers eat worms and insects instead of meat.

What should passengers do in this situation? Try to transfer the bus to another driver, leaving power in the hands of a minority? But this will not change the situation, since the coming total unemployment is inevitable. Therefore, there is only one option left - to become the authorities themselves and ride the bus without restrictions, as long as they want/need.

In the example with the conditional "bus", we see that the person on duty on the "bus" not only supervises the driver, but also holds meetings - voting of passengers, being one of them.

The principle does not change. **The duty Representatives from the population**, similarly, will supervise the servants of the people and ensure the holding of votes - Citizens' Assemblies, at all territorial administrative levels of the country (when required).

By this, ensuring the continuous functioning of the Supreme Authority of the country - **the PERMANENTLY OPERATING NATIONAL REFERENDUM** (CITIZENS' ASSEMBLY).

Therefore, each citizen, under Absolute Democracy, will have two duties: to vote in referendums - Citizens' Assemblies and to be on duty when it is his turn (approximately once a month). This is the price for being the power yourself, and not under the power of someone.

Having considered, using a simplified visual example with a "bus", the principle of the functioning of Absolute Democracy, let us move on to details. Let us focus on the key points.

The formula of the majority power: **"UNITE AND RULE"**.

Question: "How to implement the above formula and unite the population of the country (any), into Citizens' Assemblies?"

Answer: "In order to unite, into Citizens' Assemblies, the population of the country, first, must unite at their place of residence, into **Primary Groups** and organize in each, alternate duty of its members". Because, it is **the Duty Representatives** from the Primary Groups, located on the territory of one micro district (or settlement), who, having gathered together, form a collegial, supervisory body of the micro district (or settlement) – **the Coordinating Committee of the Assembly of Citizens of the Micro district (CC ACM) or the Settlement (CC ACS)**.

Being representatives of their Primary Groups, the **Duty Representatives** will ensure the unification of the population of the micro district (or settlement) in **the Assembly/Referendum of Citizens of the Micro district (ACM) or the Settlement (ACS)**.

The main responsibility of the **ACM** (or **ACS**) will be to ensure the holding of Assemblies – voting, counting the results and supervision, over the implementation of decisions made by the population.

Then, all Assemblies of Citizens of the Micro districts, located on the territory of one district of the city, will have to send, from themselves, **three Duty Representatives**. Which, when gathered together, form the **Coordinating Committee of the Assembly of Citizens of the District (CC ACD)**.

Being representatives of the population of their micro districts, the Duty Officers will ensure the unification of the district population in **the Assembly of Citizens of the District (ACD)** - the highest authority of the district.

The main responsibility of **the CC ACD** will be to ensure the holding the Assembly of Citizens (of their own) District and to supervise the implementation of the decisions of the population.

Similarly, all subsequent Coordinating Committees of the Assembly of Citizens (of the district, of a city, of the region, of a country) will be created, as well as all subsequent Assemblies of Citizens, including **the PERMANENTLY OPERATING POPULAR REFERENDUM (POPR)**.

The specificity of ABSOLUTE PEOPLE'S POWER - ABSOLUTE DEMOCRACY is that it consists of two institutions: the institution of goal-setting by the population and the institution of Duty Representatives of the Population (the Supervision Institute), through which the population supervises the implementation of their expressions of will - goal-setting.

If the functionality of the institution of population target setting consists only in determining the will of the people/population, then the functionality of the institution of Duty Representatives of the Population consists in ensuring the holding of referendums - Citizens' Assemblies, at any time and at any territorial level, when the population demands it.

By and large, **the Institute of Duty Representatives of the Population** is the workhorse of ABSOLUTE PEOPLE'S POWER. Since it not only ensures the holding of Citizens' Assemblies - referendums, but also supervises the activities of all territorial administrations, including the country's administration - the government.

The fact that 100% of the adult, capable population participates in the work of the institution of target setting, voting at Citizens' Assemblies, is obvious. But these same 100% percent of the population also participate in the work of the institute of Duty Representatives of the Population, by means of taking turns on duty in their Primary Groups, at their place of residence.

Control, in the Institute of Duty Representatives of the Population, is carried out from the bottom up.

Thus, the population of the country, taking turns on duty in the **CC ACM**, will be able to control the activities of all higher Coordinating Committees of Citizens' Assemblies.

The working element of the institute of Goal-Setting of the Population is **the Assemblies of Citizens (referendums)**.

The working element of the institute of Duty Representatives of the Population is **the Coordinating Committees of Citizens' Assemblies**.

INSTRUCTIONS

STRUCTURE AND PROCEDURE FOR CONSTRUCTING ABSOLUTE PEOPLE'S POWER - ABSOLUTE DEMOCRACY

Taking into account that different countries have different administrative territorial divisions, I recommend adapting the proposed instructions to your conditions.

The structure of Absolute People's Power is as follows:

The supreme authority of the country is

the PERMANENTLY OPERATING POPULAR REFERENDUM (POPR);

the supreme authority of the region (state, region, land) is **the permanently operating Assembly of Citizens of the Region (ACR);**

the supreme authority of the city is

the permanently operating Assembly of Citizens of the City (ACC);

the supreme authority of the district (urban or rural district) is

the permanently operating Assembly of Citizens of the District (ACD);

the highest authority of a settlement or micro district of a city (polling station), is

the permanently acting Assembly of Citizens of the Settlement (ACS) or Citizens of the Micro district (ACD).

The permanent functioning of the Assemblies of Citizens (all of the above), including the National Referendum, will be ensured by the Duty Representatives from the population, who (having gathered within the territorial boundaries of their Assemblies of Citizens) form the Coordinating Committees of the Assemblies of Citizens.

The construction of the institution of ABSOLUTE PEOPLE'S POWER begins directly with the unification of the population.

The first unification: unification of the country's population, by place of residence, into Primary Groups, approximately 40 people each, and establishment in each group of alternate duty of its members, on the basis that each is on duty approximately once a month.

The number of members in the Primary Group may vary, based on the compactness of residence.

As a Duty Officer, each will represent his Primary Group and ensure its connection with other Primary Groups of his neighborhood or village, through their Duty Representatives.

During the period of the establishment of Absolute Democracy, it is advisable for Primary Groups to be formed not by 40 people, but by 40 families (apartments or houses, in the private sector). So that any family member (who has time) could be on duty for his family/apartment.

After the establishment of Absolute Democracy in the country, it will be possible to move from door-to-door duty to nominal duty (and from one-day duty to 2-3 days, once every 2 months), since people will then receive, for the time of duty, release from work with salary retention.

The second unification: unification of Primary Groups of one micro district (or settlement) into a permanent Assemblies of Citizens of Micro districts (**ACM**) or Settlement (**ACS**).

In order for this (second) unification to take place, each Primary Group, located in the territory of one micro district (or settlement), must delegate (for duty) its Duty Representative.

Having gathered together, the Duty Representatives from the Primary Groups, form a collegial body - the Coordinating Committee (of their) permanently operating Assembly of Citizens of the Micro district (**CC ACM**) or Settlement (**CC ACS**).

The functions of the **CC ACM** and **CC ACS** will be as follows:

- a) ensure the holding of the Assembly of Citizens of the Micro district (or Settlement), that is, ensure the holding of votes (of their) citizens;
- b) supervise the activities of the administration of their micro district (or their settlement), while simultaneously monitoring the execution of the will - tasks (instructions) of the population;
- c) collegially, to represent the power of the people - the power of the Assembly of Citizens, in the intervals between assemblies - referendums, thereby supporting the constant functioning of the **ACM** or **ACS**;

d) to control the work of the higher Coordination Committee (**CC ACD**). Because control under Absolute People's Power comes from below, from the population, and not from above, from the government, as today.

The permanent Assemblies of Citizens of Micro districts (**ACM**) and Settlements (**ACS**) will be basic assemblies, since the population (members of Primary Groups) will vote at their place of residence, directly at these Assemblies of Citizens, which will simultaneously perform the functions of polling stations (i.e., polling stations, according to the old terminology).

Then, the results (votes) will only be added up. At the district level, at the city level, at the regional level and ultimately at the country level. After which the voting result (the referendum result) will be announced - the will of the people.

The third unification: Unification of permanently acting Assemblies of Citizens of the Micro districts or Settlements located on the territory of one district, into a permanently acting Assembly of Citizens of the District (respectively, of an urban or rural district).

For this unification to take place, each **ACM** (or **ACS**) located on the territory of one district must send **three of its Duty Representatives** on duty (the duty period is 3 months).

Having gathered together, the Duty Representatives from each **ACM**, one district of the city (or from each **ACS**, one rural district), form a collegial body - the Coordinating Committee of the permanently acting Assembly of Citizens of the District (**CC ACD**). Respectively, of an urban district or rural district.

The functions of the **CC ACD** will be as follows:

- a) ensure the holding of Citizens' Assemblies of their district;
- b) supervise the activities of the administration of their district, monitoring the implementation of tasks - the will of the Assembly of Citizens of the District.
- c) collegially, represent the power of the people - the power of the Assembly of Citizens of the District, in the intervals between assemblies - referendums;

d) control the work of the higher Coordination Committee (**CC ACC**).

The fourth unification: unification of permanently operating Assemblies of Citizens of the Districts located on the territory of one city, into a permanently operating Assembly of Citizens of the City (**ACC**).

In order for the unification to take place, each **ACD** of the city must send from itself, three Duty Representatives (rotation period of 9 months), who, having gathered together, form a collegial body - the Coordination Committee of the permanently operating Assembly of Citizens of the City (**CC ACC**).

The functions of the **CC ACC** will be as follows:

- a) ensure the holding of Assemblies (referendums) of Citizens of the City;
- b) to supervise the activities of the city administration, monitoring the execution of the will - tasks (instructions) from the citizens of the city.
- c) collegially, to represent the power of the people - the power of the citizens of the city, in the intervals between meetings - referendums;
- d) control the work of the higher-level Coordination Committee of the Assembly of Citizens of the Region (**CC ACR**)

The fifth unification: unification of the region's population into a permanent Assembly of Citizens of the Region (**ACR**).

In order for the population of the region to unite into the **ACR**, the population of the region will need to delegate three Duty Representatives from every 100 thousand residents (the term of duty is 15 months), who, having gathered together, form a collegial body Coordination Committee of the permanent Assembly of Citizens of the Region (**CC ACR**).

*Example/explanation - if 300 thousand people live in a city, then from this city, 9 Duty Representatives will be sent to be on duty in the **CC ACR**. The rural population, in order to send their Duty Representatives to the ACCR, will need to unite into a district (possibly from several districts) in order to recruit 100 thousand people.

The functions of the **CC ACR** will be as follows:

- a) ensure the holding of the Assemblies of Citizens of the Region;
- b) supervise the activities of the administration (government) of the region, simultaneously monitoring the execution of the will-tasks (instructions) from the citizens of the region.
- c) collegially, represent the power of the people - the power of the citizens of the region, in the intervals between assemblies - referendums;
- d) monitor the work of the higher Coordination Committee (**CC POPR**).

The sixth unification: unification of the population of the country in PERMANENTLY OPERATING POPULAR REFERENDUM (**POPR**).

In order for this unification to take place, each region of the country must send three of its Duty Representatives on duty (the term of duty/rotation is 24 months), who, having gathered together, form a collegial body - the Coordinating Committee of the PERMANENTLY OPERATING POPULAR REFERENDUM (**CC POPR**).

The functions of the **CC POPR** will be as follows:

- a) ensure the holding of **POPR** - All-People's referendums;
- b) supervise the activities of the government of the country, simultaneously monitoring the implementation of the will-goals of the people;
- c) collegially represent the power of the people, in the intervals between referendums.

Absolute People's Power operates according to the same dialectical formula (principle) as the Just Mode of Social Production - the mode of production of the formation following capitalism.

In paraphrased form, the formula looks like this:

THE POPULATION (Consumers) **BY POWER OF THE ABSOLUTE RIGHT OF THE PEOPLE TO SUPREME POWER IN THE STATE, COORDINATES** (acting as an employer) **THE GOVERNMENT** (provider of services for the population), **WITH THE PURPOSE OF SATISFYING THEIR NEEDS, ISSUE THE GOVERNMENT SPECIFIC TASKS, APPROVED BY THE POPULATION IN REFERENDUMS.**

(The basic, macroeconomic formula is on page 52).

The dialectic of the above formula is that the people experience on themselves (on their own skin) the quality of the decisions they make, and since power is constantly and invariably in the hands of the people, then if the population makes an incorrect decision, it (the population) will always correct the situation, i.e. re-vote.

The population, having organized itself into an institution of Absolute People's Power, immediately acquires the full moral and legal right to declare a **PERMANENTLY OPERATING POPULAR REFERENDUM** the Supreme Authority of the country, standing above all existing branches and structures of power (in the Russian Federation, according to Article 3 of the Constitution).

THE CONSOLIDATED DEMAND OF THE ENTIRE PEOPLE, NO ONE CAN IGNORE.

BY ESTABLISHING ABSOLUTE PEOPLE'S RULE, THE PEOPLE WILL BEGIN TO RULE THE COUNTRY BY MAKING THE DECISIONS THEY NEED.

The order of decision-making by the population is as follows:

if the issue is of local importance (at the level of district competence), then it is resolved by the Permanent Assembly of Citizens of the District;

if the issue is at the level of the city's competence, then it is resolved accordingly by the Permanent Assembly of Citizens of the City;

if the issue is at the level of the region's competence, then it is resolved by the Permanent Assembly of Citizens of the Region;

if the issue concerns the interests of all citizens of the country, then it is resolved by A PERMANENTLY VALID NATIONAL REFERENDUM.

After the votes are counted, the voting result becomes law, binding on all.

The technology of decision-making by the Citizens' Assembly (at any level) is as follows: first, mandatory public debates are held of the authors of projects (proposals) and expert speeches.

Upon completion of which, the population, through a referendum, approves the project or solution option that the majority likes.

At the stage of discussing projects, there may be a positive use of AI, which will act as a basic opponent and filter in the selection of projects/proposals, which will help the population navigate more quickly when making decisions.

As soon as **the PERMANENTLY OPERATING POPULAR REFERENDUM** is officially approved as the Supreme Authority of the country, then the status of the Coordinating Committees of all Permanent Assemblies of Citizens will immediately change.

Accordingly, the status of the Duty Representatives of the Population (forming these Committees), who will already officially begin to supervise (monitor) all branches of government, including all law enforcement agencies, will change.

In the event of detection of a serious violation, the Duty Representatives will have the right (by collegial decision) to suspend the action or activity of any official, of any government structure, until the final decision is made by the people.

Figuratively speaking, in cases similar to those described above, the **Duty Representatives from the Population** will function (work) like an electric fuse.

The quality of the Duty Representatives from the Population will be taken care of by the population itself, which will approve at Citizens' Assemblies, lists of Duty Representatives (of all levels) and control their work from below.

Thus, every capable Citizen of the country, approximately once a month (having taken up duty, from his Primary Group), will control the work of the Duty Representatives from the Population of a higher level, and through them, the work of the following Duty Representatives.

In the event of improper performance of their duties, the Duty Representatives from the Population may be recalled by the lower Duty Representatives or the population that approved them in the list (schedule) of those on duty.

If one Duty Representative from each Primary Group is sent to the Coordination Committee of the Permanent Citizens' Assembly of the Micro district (or Settlement), then three Duty Representatives are sent to all other Coordination Committees (district, city, region and country) in order to exclude incorrect exchange of information. Also, the presence of three Duty Representatives at once expands their operational capabilities and ensures continuity.

Because it allows for the change (rotation) of those on duty gradually/stage by stage, that is, one at a time, and not all three at once (i.e. the two remaining Duty Representatives will brief the one who has just taken over).

After the establishment of Absolute People's Rule, the duration of duty may be changed.

The selection of Duty Representatives from the population, for each subsequent level, will be more strict - demanding, from the point of view of competencies. The selection of Duty Representatives from the population to the highest level (for inclusion in the duty schedule), to the Coordinating Committee of the PERMANENTLY OPERATING POPULAR REFERENDUM (NATIONAL ASSEMBLY), will already be on a competitive basis.

After the establishment of Absolute People's Power, the need for a secret ballot will disappear as unnecessary. The voting procedure itself will also be simplified. It will become remote and prompt.

For example, a voter will only need to call one of three phone numbers from his personal phone number. This call will be equivalent to a decision for, against, or abstain.

In order to prevent falsifications, after the vote, printouts of all calls must be published so that everyone can check that his vote was counted correctly.

In order to conduct full-fledged nationwide discussions of goal-setting and other problems, special television channels should be created: the main state channel for discussions and debates on issues concerning everyone - the entire country; regional channels for debates and discussion of local problems.

So that representatives of science, experts, representatives of existing parties (if any) and the public, i.e. everyone who has something to say on the essence of the raised issue or problem, could speak on these channels without fail. There should be platforms for discussions and debates at all levels, starting with the level of the Permanent Assembly of Citizens of the Micro district and Settlement.

It should be especially noted that the Absolute People's Rule is exceptionally democratic. Since almost everyone will have the opportunity to make their own proposal or comment, being on duty once a month, from their Primary Group, in the Coordinating Committee of the Permanent Assembly of Citizens of their Micro district or Settlement.

And if the proposal is supported by the majority of the Duty Officers from the Primary Groups (Micro district or Settlement), then this proposal will be submitted to the Permanent Assembly of Citizens of the Micro district (or Settlement).

If the Permanent Assembly of Citizens of the Micro district (or Settlement) votes for the proposed proposal (comment), then it will be submitted for discussion to the Permanent Assembly of Citizens of the District, and so on.

Thus, current issues and decisions from below, gaining more and more support, will be pushed up, to the judgment of the public, to the judgment of the majority.

The tasks facing the Coordinating Committees of the Assemblies of Citizens and members of the Primary Groups (the population) before the establishment of Absolute People's Rule and after, will differ significantly. Thus, during the period of establishing Absolute People's Power, the efforts of all Coordinating Committees of Citizens' Assemblies and members of Primary Groups will be directed at agitation and assistance in self-organization, of the population that has not yet united into Primary Groups.

Because the first goal is to unite the population into Primary Groups.

Thus, having united into Primary Groups, and then into Assemblies of Citizens of Districts and Assemblies of Citizens of Cities, the people will become the main, consolidated political force.

Organizing, after this, into a complete structure - the institution of Absolute People's Power (according to the instructions on page 15) will be a simple matter.

It should be understood that it is enough for the population to self-organize in the ten largest cities of the country, as the question of establishing people's power will be a foregone conclusion. But this does not mean at all that the process of self-organization should be slowed down in other cities. The full functioning of the permanent Citizens' Assemblies (since their main function is goal-setting) will begin when Absolute People's Power is established. Before its establishment, the Coordinating Committees of the Citizens' Assemblies will have to coordinate the actions of the already organized population, in order to ensure unity. Why is unity of action necessary? Unity is necessary to prevent chaos.

For organized civil disobedience (as in India, under Mahatma Gandhi), if necessary. For the creation of voluntary people's squads to protect public order. For organized resistance to the destruction of the population.

Having established Absolute People's Power, the people will definitely move from political governance to economic governance, that is, to the next socio-economic formation, to the FAIR METHOD OF SOCIAL PRODUCTION (which is described in Chapter 5 of this Teaching, p. 50).

Why will the people necessarily move on to the next fair formation? Because the goal and meaning of any political superstructure (since the world is material) is to ensure the economic interests of the Master. In our case, the holder of power - the Master is the people.

Under capitalism, everything is controlled by money. Therefore, it is logical that all its political superstructures work in the interests of the Masters of money super-large capital. The proof of this is obvious. We have all seen how the governments of countries, synchronously, under the conductorship of Schwab, carried out and continue to carry out the transition to a new world fascist order - a digital concentration camp, in the interests of the 400 richest families on the planet, to the detriment of all humanity. More precisely, on its bones, if people do not wake up and understand that humanity has only one way to salvation, this is a change in the paradigm of the power of money, to the paradigm of the power of people, that is, to Absolute People's Rule.

What is so terrible about the paradigm of the power of money? Because people sell themselves - they betray the interests of humanity in a strategic perspective, that is, they saw off the branch they are sitting on. For example, any major billionaire, under a plausible pretext, can easily build laboratories and hire "scientists" who will race to grow new modifications of deadly viruses for the next lethal pandemics.

Thus, in a similar way, AIDS and specifically COVID 19 were created in the Wuhan laboratory, with Bill Gates' money.

Today, the super-rich creatures definitely already have many times more dangerous preparations.

Unfortunately, it is not only representatives of science who are sold. Journalists (agents of influence) who bring to society a conscious lie ordered by the globalists are sold.

Gendarmes, police and military personnel are sold, ready to carry out any criminal orders of the leadership for rations. For example, in Russia, police officers are openly incited that, they say, you serve the ruling class, that is, not the people.

Accordingly, if you bring the population to poverty, then it will be very easy, from its ranks, for a stable salary, to recruit any number of policemen and gendarmes. Who, with truncheons, will drive everyone into reservations (15-minute towns - ghettos), not realizing that after completing the assigned task, they will be disposed of, like the majority of the population.

Of course, those who, for the sake of preserving their existing level of comfort/prosperity, pretend not to see the evil that is happening are no better.

The power of the minority is always a vertical (of power), headed by either a dictator or a maximally limited minority, where the execution of any order from above is categorically obligatory for everyone. Therefore, even if some official does not like to breathe chemtrails, he will breathe them without showing it. Proving his loyalty to the leadership - the Fuhrer, understanding that otherwise, he will be deleted from the vertical.

The power of the majority is always a horizontal (of power), where the final decisive word is always with the people (referendum).

CHAPTER 2 WHAT TO DO

The first thing that the population of each country needs to do is to unite at their place of residence in Primary Groups and establish in them a rotating duty of its members. Having established with this action the foundation for the construction of Absolute People's Power and, at the same time, giving a start to its establishment. But for the population to begin to unite into PRIMARY GROUPS, it is necessary for the idea of establishing Absolute People's Power, to take hold of the masses. And for this, it is necessary to convey it to the masses.

The question is, how to do this without having access to the media (Mass media)? Since practically all central media belong to or are controlled by the globalists and their lackeys - the presidents of countries.

Therefore, there is only one way out. Each person who has received the real Teaching, should begin to spread it, in all possible ways, without sparing his life. Quantity can turn into quality. Accordingly, if we strain ourselves as a whole world, we will be able to create a dominant - necessary for all of us, public opinion.

How to spread the Teaching?

One of the most reliable ways of spreading is spreading by e-mail. Thus, using your phone or laptop, everyone can send this Teaching daily to many addresses, in their area, in their city, to other cities of the country and beyond its borders - everywhere. Until the idea of **establishing Absolute People's Power (Absolute Democracy) takes hold of the masses** (at least, the population of the leading countries of the planet).

As an option for distribution - you can print out a part of this Teaching (for example, from page 1 to page 37) and paste them in the form of leaflets in public places or put them in mailboxes.

Also, leaflets can be distributed in crowded places, to passers-by, to students at universities (since young people are the most active part of the population).

Those who know programming can create programs for automatic distribution of the Teaching/Doctrine.

The best option is create websites (many of them), upload Doctrine, and make links. Incognito, you can draw graffiti in crowded areas (such as **The main book of humanity** or another catchy title). Alternatively, you can distribute flyers with links to the website on the walls of houses, educational institutions, bus stop, etc.

If there are contacts abroad, then it is necessary to send there as well. Since we have one common mortal enemy - the super-rich world elite, which is today implementing a program for the utilization - murder of humanity.

In order to knock the ground out from under the globalists, humanity needs to act as a united front. People have nothing to divide among themselves. **People need a world without wars, hunger, pandemics and chemtrails.**

If a separate site or a separate distributor can be easily blocked, then it will be impossible to stop the mass distribution of this Teaching by everyone who has it.

"ONLY THE MAJORITY HAS THE POWER TO ESTABLISH THE POWER OF THE MAJORITY"

Therefore, everyone's participation is necessary. Since only the active distribution of this Teaching by everyone (who has received it) will allow us to convey the idea to the masses - to compensate for our lack of access to the media.

"RESCUEING THE DROWNING, DELIVERY OF THE DROWNING THEMSELVES"

Who are the drowning people today? Almost all of humanity. Who is drowning it and intends to dispose of it on a planetary scale? The organizers of the new world order are the organizers of a digital concentration camp for humanity. What conclusion should we draw? Elementary: "If you do not actively fight - to reason with those afflicted with **the syndrome of learned helplessness** and the infantile, zombified by television, then you will definitely be sucked into a funnel formed by billions of future drowned people." What does it mean to reason with? It means explaining to ordinary people that the existence of a state serving the interests of the people - the nation, is possible only under the condition that political power is in the majority, and not in the minority, as it is now, throughout the world.

The first thing that everyone needs to realize is the fact that we - the people, today have only one resource, WE ourselves, and that no one will help us except ourselves.

Therefore, **there is no need to wait for leaders**. It is necessary to act independently. **To become leaders ourselves**. Initiate the creation of Primary Groups in your city, and then initiate their unification into permanent Assemblies of Citizens of the Districts, and further, into a permanent Assembly of Citizens of your City.

Why is it wrong to expect a leader? **Because only an idea can act as a leader today, since an idea is immortal - the best leader!**

You can't put handcuffs on an idea!

Only the naive can think today that the ruling minority, will allow a people's leader capable of leading the masses to publicly appear.

Bloggers and socially responsible public figures need to bring the idea of establishing Absolute People's Power to the top and promote self-organization of the population in their district, in their city, and beyond.

Why should we specifically disseminate and popularize the idea of Absolute People's Power, and not another version of power?

Because there can only be one consolidating idea. Any division is the path to defeat. After the victory over the globalists, when the threat of destruction of humanity is removed, each nation will figure out what it needs. Absolute People's Power, just allows this to be done, since under it, it is the people who are the Master and no one else. Absolute People's Power is more direct than any existing direct democracy.

THE ESTABLISHMENT OF ABSOLUTE PEOPLE'S POWER CONSISTS OF TWO PHASES.

The first phase is communicating to the masses, knowledge of the path to establishing Absolute People's Power.

Because without explaining to the masses what Absolute People's Power is, and how to establish it, it is useless to call on the population to unite and self-organize. It will be a different matter when everyone knows why and how to establish it.

The second phase is the establishment of Absolute People's Power.

"KNOWLEDGE OF THE PATH TO THE ULTIMATE GOAL BY EVERYONE WILL BE A GUARANTEE OF ITS ACHIEVEMENT"

Why will knowledge of the path to building Absolute People's Power by everyone guarantee of its establishment? Because, in this case, no one will be able to lead humanity astray (even by heading it, in some separate country, with the aim of intercepting control).

When everyone knows the essence - that the Supreme Authority of the country, must be a **PERMANENTLY OPERATING POPULAR REFERENDUM**, and the highest authority of each city a **PERMANENTLY OPERATING ASSEMBLY (REFERENDUM) OF THE CITIZEN CITY**

+ know the supervisory powers and functions of the Duty Representatives of the population, including knowledge of their own place in the general system, then the establishment of Absolute People's Rule will be accomplished.

Why is the first phase extremely important? Because, without completing the first phase, it is pointless to proceed to the second.

For example, you will go to agitate, and they will look at you as if you were aliens. When (after the artillery preparation - the first phase) all those capable of adequate thinking (including policemen, military men, gendarmes, corrupt journalists, etc.) begin to understand that the new world order is categorically contraindicated for everyone - mortally harmful, since in it only the super-rich elite have a future, while the rest have slavery, lawlessness and utilization. Then public opinion will begin to change in favor of establishing Absolute People's Power and it will be possible to begin implementing the second, final phase.

Specifically, one can say only one thing: "The speed of us/all implementing the first phase will predetermine the possibility of implementing the second phase, that is, it will predetermine the probability of establishing Absolute People's Power."

Knowledge of the essence and the way to establish Absolute People's Power by everyone gives a huge tactical advantage. Thus, all citizens of the city, united in Primary Groups, will know that together, they already **are the Assembly of Citizens of the City** - the highest authority of their city.

Minority authorities can easily strike at decision-making centers (popular movements), decapitating them.

It is another matter when the people can first self-organize into Primary Groups on the territory of the city, and then quickly create Coordinating Committees of Citizens' Assemblies (or bring out of the shadows, already created **CC ACC**).

In order to defeat the globalist creatures today, the population does not need to climb the barricades, seize the post office and telegraph. It is enough for the majority to unite everywhere in Primary Groups.

Then, at the appointed hour, everyone should go out to the city squares and announce the establishment of Absolute People's Rule in their country.

Everyone needs to understand that the organized vertical of power of the ruling minority today can only be resisted by an organized structure of power of the population united in the institution of **ABSOLUTE PEOPLE'S POWER**. In order to launch the process of self-organization of citizens in Primary Groups in any city, a small team is enough, the task of which will be to start 3- Primary Groups in each district of your city. Who, then themselves, will also organize the population into Primary Groups in their area and further.

The team inducing the process of unification of the population into **Primary Groups** can position itself as a gathering point for the future **Coordinating Committee of the City Citizens' Assembly**.

The City Citizens' Assembly will gain strength and meaning only when a significant part of the city's population (100,000 people) is organized into Primary Groups. After that, the unification process will proceed in geometric progression. Therefore, all available human and information resources, first of all, will need to be directed to agitation and assistance to the population in unification into **Primary Groups**.

For this purpose, on weekends, it would be advisable for members of the Primary Groups to organize agitation raids (in the days off), in order to speed up the process of unification of city citizens several times. During the period of the formation of Absolute Democracy, the Duty Representatives from the Primary Groups, being a permanently active asset, during their duty, will also have to engage in population agitation and supervise its unification into Primary Groups.

For the convenience of the above-mentioned task, the Duty Representatives from two neighboring Primary Groups can join and, in pairs (or threes), go to houses whose residents have not yet organized into Primary Groups.

The principle of recruitment into the Primary Group is voluntary. If the residents of any apartment refuse to join the Primary Group, then it is necessary to move on to the next apartment.

Of course, before offering to join the Primary Group, it would be advisable to distribute agitation leaflets (materials) in mailboxes in advance.

To unite the residents of a specific house into Primary Groups, a house chat can be created. Similarly, it makes sense to create a **chat micro district** (a polling station – a part of district).

During the period of establishing Absolute Democracy, Citizens' Assemblies will be needed only for the approval of the Duty Representatives from the population. Citizens' Assemblies will fully function after the establishment of Absolute Democracy.

Also, during the period of establishing Absolute Democracy, three Duty Representatives from the population of each micro district (in "violation" of the Instructions given on page 15) will represent the population that delegated them, not only in the Coordinating Committee of the Citizens' Assembly of the District (**CC ACD**), but also in the Coordinating Committee of the Citizens' Assembly of the City (**CC ACC**). Why? In order to make the presence of the Duty Representatives of the population in the **CC ACC** more massive, and also to make the contact between the Duty Representatives, forming the **CC ACC**, and the citizens of the city - members of the Primary Groups, more rapid.

For the same purpose, the Duty Representatives from the Primary Groups can take part in the meetings of the **CC** of their district.

At the moment of transfer of power to the people, the Coordinating Committees of the Citizens' Assemblies are necessary so that there is someone to take state structures under supervision. So that there is someone, standing above the state structures, to hold each official and general who does not want to submit to the will of the people accountable.

Of course, all security structures will have to immediately come under 100% supervision of **Coordinating Committees of Citizens' Assemblies** and ask their permission for any action. For this purpose, to each first person of the supervisory staff there should be attached Duty Representatives from **CC** of the appropriate level, who will oversee his work and inform their **CC** of everything that happens.

When Absolute People's Rule is established, then the institution of Absolute People's Rule will begin to work according to the Instruction.

Today, the globalists have covered the entire population of the planet with a disinformation cap. Therefore, people do not see the trends and essence of what is happening. They continue to live by yesterday's goals - the desire to earn more money, to go to school to become successful and to earn even more money, when the question today is glaring: "To be or not to be humanity?"

A very small part of the population realizes the horror of what is happening. Only a few reveal the plans of the utilizers of humanity, but only in the Teaching I propose is it written what must be done now to defeat global evil.

The consciousness of the masses today (formed by capitalist existence) is every man for himself. Therefore, in order to rule over us, we don't even need to be divided (since we are already separated). It is enough not to allow us to unite. Our task is to explain to humanity that only by establishing Absolute People's Power, the peoples of countries will be able to take control of the present and move on to the future.

Therefore, we need every adult inhabitant of the planet (regardless of class affiliation) to know that capitalism is living out its last hours and that humanity today has only two paths: the first path to the future - evolutionary, where everything will be done for the sake of people, the path to the golden age of humanity, to a fair formation without antagonisms; the second path to the past - de-evolutionary, along which the governments of countries (by order of the world government of globalists) are now leading us all to an electronic concentration camp for disposal and transformation of those who are "lucky" into slaves - service people (people without rights and property) - into subhuman.

When agitating the population, it should be taken into account that the majority of people today have formed the following false stereotypes:

a) The majority cannot rule (be the Master of the country), only the minority can rule;

Refutation: The result of the rule of the minority - the elite, is evident today. Wars have not stopped, the threat of nuclear war is relevant today - it is on the agenda. General prosperity has not come.

On the contrary, life on all continents is getting worse every day. All this is a consequence of the rule of the minority - 1% of the population, which owns 90% of all the wealth of the planet.

b) The people are needed by globalists to make money (exploit), and therefore the utilization of the population is not profitable for them;

Refutation: It should be understood that the entire super-rich world elite is a relatively small part of the planet's population (less than 1 million) and they do not need so many factories, mines, and, accordingly, do not need so much population, which, moreover, is today being actively replaced by robots and fully automated technologies.

The world's super-rich elite needs an ecologically clean planet, with a minimum number of industries, and a minimum number of population - enough to serve one million masters of the new world order. They do not need extra slaves. Socrates said: "As many slaves as you have, so many enemies you have."

c) We cannot change anything, we are powerless before the repressive state machine and the bureaucratic vertical of power (learned helplessness syndrome);

Refutation: Individually or as a separate group, we, citizens of any country, of course, cannot oppose anything to the repressive state machine, but when we unite, all act as a united front, demanding that power be transferred to the people, then the police and representatives of the ruling elite will scatter like rats from a sinking ship.

d) Capitalism is eternal, there cannot be a fair social formation;

Refutation: Capitalism is finite due to technical progress (as I have already noted). Because when automation and robotization of production occurs, the bulk of the population will become unemployed - insolvent. Then, the capitalists will have no one to sell their products to and capitalism will collapse.

Socialism failed for two reasons.

The first is the failure to fulfill Marx's order, which indicated **that after the revolution, power must be transferred to the people.** The power-hungry ignored his instructions. Power in the USSR, was always in the hands of a minority - the elite (the General Secretary and the Politburo). The power of the people, was always exclusively declarative.

If political power in the USSR was in the hands of the people, the USSR would never have collapsed, since the Soviet people voted in a referendum to preserve it. But the will of the people, their "servants", was brazenly ignored.

The second reason is that the problem of finding and specifying a mechanism to ensure progress under socialism-communism, the solution of which Karl Marx sent to us, into the future, was not solved.

Only by revealing the dual nature of competition, I solved the problem posed by Marx.

(the structure and functioning of a fair socio-economic formation following capitalism is described in detail in Chapter 4 and Chapter 5 of this Teaching).

e) The government does everything for the good of the people, and state TV channels always tell the truth.

Diagnosis: Only the extremely infantile, devoid of critical thinking, incapable of seeing obvious contradictions, can reason like this.

What are the media for in an unjust society? First of all, to fool the population so that it thinks that everything is fair.

When only a society/state can be fair, where the Supreme power is in the hands of the majority.

As a motivation for residents who are offered to unite in the Primary Group, one can name the opportunity (after the establishment of Absolute People's Power) to control tariffs, from the position of a citizen-Master of the country's natural resources.

That is, to directly influence the amount of payment for electricity, gas, water, heat and other utilities. Among the advantages, one should also name the population's acquisition of the opportunity to supervise, from the position of the Master, the activities of the administration of their district, city, region, as well as the activities of the government of the country, so that they correspond to the interests of the people and their goals.

Explaining that without the supervision of the population, the servants of the people - officials, will continue to behave as the masters of the country and its citizens. Agitating for Absolute People's Power - the power of ALL, it is appropriate to note that if in every country the power was in the hands of the people, then not a single people would agree to war - to aggression. Since wars are needed only by those who get rich on them or, by means of them, hold on to power. **By creating the image of an enemy of one nation, in the person of another nation.**

By sending the controlled population to die for the realization of their own selfish interests.

Also, it should be especially noted that today, those who have the right to start a military conflict or even a war are several orders of magnitude better protected than the population. They have bunkers and even entire underground cities in which they can sit out a nuclear winter. And this is another nail in the coffin of the minority that rules today.

A separate appeal to representatives of small and medium-sized businesses. Because businesses have material resources, part of which they can use to establish Absolute People's Rule in their country. For what? In order to avoid utilization and slavery themselves. Because there will be no bourgeois brotherhood and, as a result, the middle class will lose its property - it will share the fate of the people. Representatives of small and medium businesses should understand that they are the number one target for the globalists today. Because the globalists do not need free people, and those who also have some resources. The masters of the new world neo-feudal, fascist order need uncomplainingly submissive people, no more than 900 million of whom are service people. Therefore, today they have taken a course to utilize the population and destroy the world economy, with the goal of eliminating the middle class. **The son of the fascist Schwab** openly announced to the entire planet: **"You will have nothing and you will be happy."** Isn't the plan clearly stated? The stereotype of the bourgeois mental thinking that the capitalist state will protect their private property (since it is sacred and inviolable) and all of them as a class is false today. Because the administrative resource of each state is subordinated to the vertical of presidential (or parliamentary) power, which today implements the plans of the globalists to transition to a new world order - a return to the neo-feudal system. And the serfs - service people, as you understand, cannot have property. Because the serfs themselves are the property of the masters of the new world order. The difference from the existing feudal system will only be that Artificial Intelligence will act as an overseer, which will control every step of everyone, every message, every purchase (carbon footprint). Instead of a carrot and stick, there will be a social rating. Accordingly, in case of disobedience, restrictions will be imposed on food and movement. In the event of a riot, "smart lights" and 5G towers will be turned on, as a result of which, blood clots from nano particles of metal and graphene will form in the blood.

Which are constantly sprayed from airplanes and added to vaccines.

The synchronicity of what is happening in the world suggests that control is carried out from one secret center. For example, today there is a military conflict between Russia and Ukraine, but why, at the same time, Russian military aircraft are poisoning the Russian population with chemtrails? And gray-haired pilots, in officer ranks, with a straight face, lie on TV screens that these are contrails from the work of engines, which have lined the entire sky with stripes (sometimes with a cross). The same picture is observed in Europe and the USA. Military aircraft of the Pentagon and NATO, without asking permission from the Americans and Europeans, spray chemtrails on their heads. The only difference is that they admit that they are spraying finely dispersed cement (which, for some reason, is magnetized?), allegedly to combat global warming. But the natural disasters (floods, hurricanes, droughts) shaking the planet today, say the opposite. About the use of climate weapons against the entire population of the earth (with the aim of causing widespread crop failures - famine).

Beauty will no longer save the world. Today, only the smart can save the world, armed with the doctrine of Absolute Democracy.

But where can we get a sufficient number of smart people? If we are guided by the famous statement of Bernard Shaw, then it is only two percent out of a hundred people are able to think.

How do you know that you are smart?

If you have read and understood what is written, are ready and will act, then you are definitely smart. Passive and cowardly, willing, like a sheep, to go meekly to the slaughter, is equivalent to stupid.

What is the mission of the smart? The mission of the smart is to change public opinion in favor of the power of ALL, in favor of the urgent establishment of Absolute Democracy in countries.

It is necessary to remember that we, the people, have catastrophically little time left. The globalists are almost ready to introduce digital money. In some European countries, they no longer accept cash for payment. When the gates of the digital concentration camp slam shut, you will no longer risk, not only spreading the real Teaching, but also, in general, showing any political activity. Because you will be deprived of financial sovereignty. Sovereignty of cash. All your money, having become digital, will end up with them.

Not vaccinated, with what they order, bots will block the account – you will swell from hunger. Vaccinate - you will swell from carcinogens or other infections.

The scales are on the side of Evil today - the globalists, the killers of humanity. What needs to be done to tip the scales towards Good - in favor of people? Everyone needs to do their best to reason with and unite the population, according to the Instructions (p. 15).

This is the only way we can defeat the super-rich creatures/parasites.

CHAPTER 3

To see the future, you don't need to draw historical parallels. It's enough to know the laws of development of human society.

THE FOURTH AXIOM

**THE LEVEL OF TECHNICAL PROGRESS DETERMINES
THE MODE OF SOCIAL PRODUCTION**

(since the discrepancy between production relations, the nature and level of development of productive forces, leading to a change in socio-economic formations, is a direct consequence of technical progress).

THE FIFTH AXIOM

**ANY POWER OF A MINORITY IS CRIMINAL, IN RELATION TO THE
MAJORITY OF THE POPULATION, BECAUSE THE MINORITY WILL
NEVER BE AND WILL NOT PHYSICALLY BE ABLE TO DEFEND THE
INTERESTS OF THE MAJORITY**

I will give an example from bourgeois democracy. US President John Kennedy crossed the road to the deep American government (the Money Masters). He was shot. Thus, the ruling minority annulled the results of the voting of the American people. If a similar situation arises, everything will repeat itself.

That is, if any president does not act in the interests of the elite of the super-rich minority, then he will be removed physically or through impeachment. Before John Kennedy, in 1945, Franklin Roosevelt was killed.

Using the USSR as an example, we can see how concentration of power in the minority - the party elite, even with a leftist orientation - ends. An insufficiently intellectual, cowardly creature, a henpecked Gorbachev - a careerist product of the post-Stalin party system, finding himself at the head of a superpower and the countries of the socialist camp, possessing unlimited powers, destroyed the socialist camp. Childishly believing that after his capitulatory actions, the imperialists would abandon imperialism.

But if we take into account all the disarmament treaties signed by Gorbachev, extremely disadvantageous for the USSR, including the destruction of the latest military developments, then all his actions should be qualified unequivocally, as treason.

The pseudo-communist Yeltsin acted similarly treacherously. Driven solely by lust for power, he destroyed the USSR, despite the fact that the people of the Soviet Union - 250 million voted in a referendum to preserve the country.

The examples given clearly confirm the self-interest, perniciousness, inability and unacceptability of the power of a minority for the majority. There can be only one conclusion from all of the above: **The power of a minority over the majority is categorically unacceptable.**

THE SIXTH AXIOM

**ONLY THE ESTABLISHMENT OF ABSOLUTE PEOPLE'S RULE CAN
GUARANTEE THE PROTECTION OF THE INTERESTS OF THE ENTIRE
POPULATION**

By delegating its powers to someone, society always runs a risk: **"You can't look into someone else's soul"; "Someone else's soul is a dark place."**

In the presence of the political power of the majority, this is not required. If you do not so, you will be punished - fired or imprisoned.

The bourgeois democracy that exists today is not democracy at all. It is a substitution of concepts. It is a populist lie with the aim of legitimizing the power of the ruling class by creating the visible involvement of the people in governance. Why do capitalists, who fear the power of the people most of all, advocate for the widespread establishment of bourgeois democracy? For a simple reason - bourgeois democracy is easily controlled by money. Like everything under capitalism. The positioning of capitalist society, freedoms as a society with a multitude is propaganda. Under the capitalist unjust and defective mode of production, in comparison with the **"Fair method of social production"** proposed in this Teaching (see p. 50), there are only two real freedoms. Freedom to exploit (if there is capital) and freedom to starve to death (if there is no welfare). Freedom of speech declared by propaganda, when the information space is privately owned by the ruling minority, is also illusory. Because the bourgeoisie will not allow information to be broadcast that will go against its class interests.

"Freedom of speech, without access to the media, is equal to a voice crying in the wilderness."

If we talk about parties, they generally lobby for the interests of individual groups of the population - individual minorities. This is already initially contrary to the interests of the majority. There are also no guarantees that parties that declare themselves popular, having received political power, will serve the people. In this case, the most dangerous parties are those where there is a leader and party hierarchy in decision-making.

Because such parties, from the very beginning, are oriented towards managing the minority and can easily slide into dictatorship. Delegation of powers from the majority to anyone, is wrong and harmful.

For example, the slogan: "All power to the councils" is outdated today. Because the councils that were in the USSR were already the power of the minority with a specific hierarchy, represented by the chairmen of the executive committees.

Today the correct slogan is: **"All power to the people" - Permanent Assemblies - Referendums of Citizens.**

Any people can express their will only through a referendum. But whether to hold or not to hold a referendum today is decided by the authorities, not the people. Having previously calculated and prepared through the media the necessary for it-minority authorities, public opinion.

Having a monopoly on the information space and a monopoly on managing the security forces, the authorities can always brazenly ignore the decision of the people. For example, as the renegade and careerist Yeltsin did with his accomplices, ignoring the will of the Soviet people to preserve the USSR. Why was all this possible?

Because the power structures were initially oriented - trained to serve the authorities, and not the people. To protect the top management from the people. By using administrative resources, the power of the minority can always falsify the results of a referendum.

Therefore, the people have only one way to take control of their servants - officials, ministers and presidents (so that they act in the interests of the population, and not the minority - the super-rich world elite), this is to establish Absolute People's Rule. So that everyone knows who is the Master and who should be served now. So that the people do not ask permission to hold another (necessary) referendum, but the people are asked permission for all fateful and responsible actions. **Without establishing control of the majority over what is happening, the nations are doomed.**

Who controls the composition and quality of the vaccine today? Shwab's friends and World Health Organization sponsored by Bill Gates (representatives of the trillionaires' club). Are they, what, friends of humanity?

THE SEVENTH AXIOM

TECHNOLOGICAL REVOLUTION THAT IS OCCURRING TODAY INEVITABLY LEADS TO A CHANGE IN THE EXISTING CAPITALIST SOCIO- ECONOMIC FORMATION.

The technological revolution that is taking place today will bury capitalism, just as the previous technological revolution did. When the advent of manufactories and steam engines led to the rise of capitalism and the fall of feudalism.

History repeats itself. In England, at the dawn of capitalism, there was a reaction of artisans who tried to stop progress by smashing machines, because they could not compete with them. But this was a reaction of a spontaneous nature. Today, COVID-19 is the same reaction to progress, but not spontaneous, but planned in advance by the world's super-rich elite, with the goal of stopping the evolutionary development of humanity.

To solve this problem, David Rockefeller, in 1962, created the Club of Rome. Which proposed to turn humanity 180 degrees and send it back to the neo-feudal system. Certainly, the architects of the new world order knew the law discovered by Karl Marx, which determines the change of socio-economic formations:

THE LAW OF CORRESPONDENCE OF PRODUCTION RELATIONS WITH THE NATURE AND LEVEL OF DEVELOPMENT OF PRODUCTIVE FORCES.

The essence of this law is that when the specified discrepancy occurs, a change in the existing formation is inevitable. The discrepancy of production relations under capitalism will occur when the share of human labor in the social product, becomes critically small.

In other words: **"due to the technological revolution taking place today, man will inevitably drop out of the productive forces, just as the horse once dropped out of draft power."**

Having dropped out of the productive forces, man will become unemployed, and therefore insolvent. Accordingly, the market will collapse and capitalism will collapse. The danger for the population of the planet is not that capitalism will collapse, but that the world elite - the Owners of Money, are ready for any crimes against humanity (which they are doing today), in order to prevent humanity from moving on to the next just socio-economic formation.

Because in the next formation the Owners of Money will lose the power that they have today, it is unlimited. Since the next socio-economic formation is the power of all - the people, there is the dictatorship of the Consumers (that is, us with you) over robots and machines. There is a golden age of humanity.

When the capitalist formation is the dictatorship of capital, there is the power of the minority, who own money, over the majority.

Today the world is ruled by money.

An insignificant group of the super-rich determines the fate of the planet. Therefore, there are endless wars and many other human and environmental disasters.

If the power of the majority is established, the world will be ruled by people, that is, by thoughts - justice will rule.

THE EIGHTH AXIOM

THE FINAL PHASE OF "ABSOLUTE PEOPLE'S POWER" IS THE TRANSITION FROM POLITICAL GOVERNANCE OF THE COUNTRY BY THE MAJORITY TO ECONOMIC GOVERNANCE OF THE PEOPLE

For clarity, let's clarify why the people need power? **"The essence of human existence is to satisfy his needs (all spectrum)».**

Accordingly, the people need power to satisfy the needs of each - all (and not the parasitic elite). Therefore, the economy of the next formation - **the Fair way of social production**, where **Consumers** control **Producers** by ordering them, the desired product (goods, works, services) is a way of managing the economy by the people, is the power of all - the people, materialized in production relations (See details in Chapter 5, p. 50)

Establishing the political power of the majority is only the first, extremely important phase - a step that will allow the population to control what is happening. It will allow the population not to let itself be destroyed today, and in the future it will allow a painless transition to the next socio-economic formation.

In the next socio-economic formation, the people will implement their power already in an economic way – coordinating Producers. Acting as **the Master of the means of production**.

THE NINTH AXSIOM

ANY ECONOMICALLY INSUFFICIENT SYSTEM IS DOOMED TO BE TOTALITARIAN.

If the economy stops working, then the ruling minority can only stay in power through total violence. It should be obvious from the seventh Axiom that the end of capitalism is inevitable. This was announced in 2020 by the Club of Rome, the main apologist for capitalism. The degradation of capitalism is also brought closer by the fact that, along with the automation and robotization of production, there is a process of mergers and acquisitions.

As a result, only super-large corporations will remain on the market, the competition between which will be conditional. It should also be understood that when capitalism collapses, not only the capitalist class will be out of business, but also the middle class. Therefore, practically everyone should be interested in the evolutionary transition to the next social formation. If humanity fails or fails to move on to the next (historical) socio-economic formation, it will be forcibly driven into an artificial totalitarian system, which is what we are seeing today.

There will be no automatic transition to the next social formation. Since the ruling minority - the world elite will do everything to stop the wheel of history.

THE TENTH AXIOM

EACH SUBSEQUENT SOCIAL-ECONOMIC FORMATION IS A TRANSITION TO A NEW, HIGHER LEVEL OF FREEDOMS.

For example, under the slave system, a slave has no rights. He is in the position of an animal. Under the feudal system, a common man, unlike cattle, already has some rights. He no longer works under the lash of an overseer and can have a family, but he is still completely dependent on the feudal lord, whose power and status were determined by his origin.

Under capitalism, a person is formally free. His status and power are determined by capital, regardless of his origin, nationality and religious affiliation. In the formation following capitalism, power must be completely transferred to the people. What Karl Marx was talking about (about the need to transfer power, after the revolution, to the people), of course, was not just a catchphrase.

But this, apparently, did not interest Stalin. On the contrary, from the moment he became the general secretary of the party, all his actions were aimed at personal usurpation of power. As a result, instead of the dictatorship of the majority - the proletariat (the class of representatives of hired labor), he establishes a dictatorship of the minority (the dictatorship of goats and screws).

He himself (Bloody Yoska) becomes a dictator and begins to rule everyone (including the proletariat) by means of terror. In his last letter to the congress, Lenin strongly recommends transferring Stalin from General Secretary to another position and increasing the number of members of the Politburo to 100 people. In order to ensure party democracy and prevent authoritarian rule.

Why did Stalin, who called himself Lenin's student, not fulfill the will of his teacher? For a simple reason. He really wanted power. In 1925, Stalin renames Tsaritsyn to Stalingrad - launching his cult.

The next step. Stalin turns the Chekists into mindless executors. Not long before the execution, Bukharin characterized the Chekists as follows: "They have become unprincipled and well-off, and only hide behind the glory of the first Chekists." In 1934, at the 17th Party Congress, 1,050 delegates, with the right to vote from a million communists, voted against Stalin's candidacy. Stalin knew in advance that this would be the outcome and falsified the voting results.

His catchphrase: "It doesn't matter how they voted, it matters how they counted." Subsequently, the 17th Party Congress, proclaimed as the congress of victors, was called the executed congress.

Stalin took revenge on everyone, executing 1,108 delegates out of 1,966 delegates of the seventeenth congress and executing 97 out of 139 members and candidates for membership in the Central Committee of the party. He sent the relatives of those executed to concentration camps.

Young children to orphanages. He also organized the secret murder of S.M. Kirov, for whom the communist delegates voted. Thus, Stalin destroyed the Lenin Guard.

After the 17th Congress, all other party congresses became pocket tame. A wave of repressions began - a search for enemies of the people. Since Stalin needed to eliminate witnesses of his crimes and the dissatisfied. As a result, after bloody purges throughout the country, there were no real, ideological communists left in the party leadership.

There were opportunists and careerists left. The dictator Stalin did not need ideological ones, he needed submissive ones. The cowardly groveling Stalin's entourage, having suffered fear after his death, condemned Stalin's personality cult and absolutely objectively (if we take into account the mind-boggling amount of innocent blood he had shed), declared Stalin an enemy of the people.

Declared a general amnesty for the repressed (since the Politburo was well aware of their innocence) and removed the whip, not suspecting that it was removing the core of the totalitarian Stalinist "economic" model. The main motivation, at all levels, was fear.

The post-Stalin Politburo also did not want to follow the teachings of Marx and Engels - to transfer power to the people.

The totalitarian method of governing by a narrow group (the Politburo) - a minority, was preserved.

In the USSR, it was only declaratively declared that all power belongs to the people. When in fact all power was in the hands of the General Secretary of the party and the Politburo. In fact, any General Secretary had no less power than the Russian Emperor. Each first secretary was a "feudal princeling". Therefore, the existing structure of power was more reminiscent of neo-feudal. **Accordingly, there was no transition to the next level of freedom for the population.**

On the contrary, in 1991, a return to capitalism (bourgeois counterrevolution) initiated by the party elite occurred.

Socialism is a system of free people, without overseers and dictators. If there are overseers, then there are slaves and slave owners. The authoritarian model of governance built by Stalin, aimed at serving the supreme ruler (the Master-dictator), and not the people, turned out to be a time bomb. As soon as the traitor Gorbachev (a careerist without ideas) found himself at the top of power, all state structures began to work for him and his betrayal. As a result, all the titanic efforts of the Soviet people to build the society of the future, all their losses, everything was reduced to zero. Stalin also played a dirty trick on the countries that had embarked on the path of socialist construction, by imposing on them his own, distorted by the dictatorial version, patterns that discredit the left/communist idea. Stalin is credited with the victory in the Great Patriotic War as his main achievement. Accidentally forgetting that before the war he beheaded the army, shooting almost all the top command staff and this resulted in the people's unjustified loss of many millions of lives. Konstantin Zhukov said that Stalin began to understand something in military affairs only in 1943. Today, the bloody dictator, the direct culprit of the murders of hundreds of thousands of innocent people, is called an effective manager. Why? To glorify dictatorship as an effective way of managing. For this, people were confused with facts, so that they would see black as white (classic according to A. Dulles).

THE ELEVENTH AXIOM

ONLY A SOCIETY WHICH HAS POWER FROM THE MAJORITY, NOT THE MINORITY, CAN BE FAIR

THE GORDIAN KNOT OF THE PROBLEM OF SOVIET ECONOMY

What ensures progress under the capitalist mode of production? Definitely competition. Under the socialist mode of production, there should be no competition between producers.

Marx and Engels talked about this, and it is absolutely true. What then should replace competition and induce progress under a socialist economy? Socialist emulation? A plan? Labor productivity?

Of course not. Because progress, from the point of view of social production, **is the creation of products (goods, works, services) with new (or superior) properties**, that is, the production of products with a new use value.

Accordingly, for the functioning of the socialist formation, a mechanism is needed - a Mode of Production that will force Producers to produce products with a new consumer value, without a market - without competition with other Producers.

What did the classics say about the mechanism of progress under socialism? Marx and Engels gave only a dialectical justification of its existence. Having said **that the satisfaction of some needs will cause new ones, and since the means of production will belong to everyone and will work in the interests of everyone, then conditions will be created for the satisfaction of new needs.**

The discovery of the very mechanism of progress of the coming formation, Marx and Engels addressed to us, to the future. Unfortunately, academics and doctors, including those from the Soviet economic science, were unable to solve this problem.

In 1987, **having revealed the dual nature of competition**, I solved the problem set (before the descendants) by Marx and Engels - I discovered **the mechanism that ensures progress under the socialist mode of social production** and wrote a macroeconomic formula that ensures the functioning of socialism-communism.

Thanks to my discovery, the immortal Teaching of Marx and Engels received the missing link.

A monograph on the above topic (as I have already noted) was published in the scientific and theoretical journal "Communist Herald" in 1996, entitled, as: **"A FAIR MODE OF SOCIAL PRODUCTION"**.

I began my immersion in the problem with an analysis of competition - a condition ensuring the progress of capitalism. Having revealed the dual nature of competition, namely, that competition, on the one hand, **is a struggle between producers for the consumer**, and on the other hand, **is a condition that allows consumers to influence producers (which is primary)**, I derived the main law of macroeconomics, which states:

NOT A SINGLE SOCIAL AND ECONOMIC FORMATION WILL FUNCTION IF CONSUMERS IN IT CANNOT INFLUENCE PRODUCERS

In the USSR and the countries of the socialist camp, they tried to build socialism without knowing the main law of macroeconomics, therefore, the construction of real socialism did not work out. The scientific economic community could not understand that the main condition ensuring progress of any mode of production (capitalist, socialist) is the consumer's ability to influence the producer.

But there was a second, primitive way of ensuring progress that could be used.

For example, tanks, missiles and planes in the USSR were no worse, but better than in the USA. Why? Because there was a hidden (conditional) competition - an arms race. If we in the USSR, in the production of consumer goods and in other areas, also focused on the achievements of the opposing side. Without advertising costs, losses from overproduction and having the ability to purposefully spend financial and other resources, we would have created a powerful production base, and would have had every chance of overtaking the capitalist countries in all indicators. But the one-sided policy of chasing the plan (which gave rise to padding) chasing quantity that does not turn into new quality, led only to the degradation of the economy.

Gorbachev shone with stupidity. He proposed that workers elect their own directors. What kind of director - boss will the workers (labor collective) choose for themselves?

Definitely not a demanding one, but on the contrary, prone to familiarity. In practice, this is how it turned out.

Then Gorbachev took the course towards capitalism, which was even greater stupidity. Because capitalism was already entering its final stage (today we see how the ongoing crisis is shaking the world economy). We needed to move from pseudo-socialism to real, correct socialism.

Starting in 1989, "Marketers" were already sitting in the economic departments of all central editorial offices of newspapers and magazines. They categorically did not allow materials with an anti-market orientation, following the unspoken instructions from the authorities, despite the declared glasnost. Therefore, there was no public discussion. Everything went according to the rules of the current administrative command system.

The General Secretary said: "Everyone to capitalism." The entire party leadership and all the first secretaries reported: "Yes, sir." Before this, having blocked off the main squares of large cities, including Moscow, with various buildings. Fearing that the people will not support their behind-the-scenes solidarity for a return to capitalism.

When the question of privatizing enterprises arose, I explained the future prospects using a simplified example: Let's say that our sewing factory currently produces 1,000 trousers a year. If we give the factory to a seamstress (manufacturer), she will produce less and sell them at a higher price. If we hand over the factory to consumers of the products of this factory, she will not only continue to produce 1,000 trousers, but will sew them of the required quality and assortment.

In fact, it turned out like this: the seamstress-manufacturer did not sew anything at all. She handed over the machines for scrap metal, leased the territory, and took the proceeds offshore. Having appropriated the people's property.

Today in Russia, the Stalinists sang Hallelujah to the Stalinist "economy". Yes, there is a "good" visual example. The Suez Canal was dug in 10 years. The Panama Canal in 42 years, where the human losses for the entire time were 25 thousand people (due to malaria). And the White Sea Canal was dug in 20 months, at the cost of 300 thousand lives. If 500 thousand lives had been lost, the canal would have been built even faster. Impressive economic achievements, in terms of price and time. The cult is worth a lot.

If fear can motivate labor activity among slaves, then consciousness, among free workers and the intelligentsia, definitely cannot motivate labor activity.

Only payment according to work can motivate.

To each according to work, this is the basic principle of socialism.

In the USSR, we had equalization, which negatively affected labor productivity. But it is necessary to clearly understand that labor productivity depends first of all on technical progress, on new technologies and automation of labor, and not on biological characteristics and motivations of the person performing the work. For example, the average truck of 1950 could carry 3-5 tons at an average speed of 40 km/h. Today, the average truck carries 20-40 tons at an average speed of 80 km/h. Moreover, the working conditions of the driver have improved many times over.

I touched on the topic of labor productivity because it has always been positioned as a key one and it was this that served as the reason for my analysis of the Soviet economy.

The first thought was this: the socialist formation is an order of magnitude higher than the capitalist one, but productivity is lower. It should not be so. The contradiction is obvious.

The second thought was aimed at competition, at its analysis, since it is competition under the capitalist mode of production that ensures progress and, accordingly, growth in labor productivity.

Considering competition, I found that the struggle between producers (for the consumer) is only the tip of the iceberg.

The underwater (main) part is the ability of consumers to influence producers. **Thus, I derived a macroeconomic formula for the functioning of the socialist-communist formation.**

According to socialist political management from above the economy does not require.

Socialism is a system where the population plans the production of consumer goods (works, services), from below, by means of orders, setting the pace for the rest of industry.

FAIR METHOD OF SOCIAL PRODUCTION

To make everything clear to everyone, before naming the macroeconomic formula that ensures the functioning of a FAIR METHOD OF SOCIAL PRODUCTION, I want to reveal the simple essence of the economy by answering the question: "What are economic relations?"

Economic relations are relations between PRODUCERS and CONSUMERS.

The Consumer and the Producer are the main participants of the entire economic process (the fewer intermediaries there are between them, the lower the price of the goods-products for the Consumer).

But for the economy to work - economic relations to take place, it is necessary to fulfill the main condition:

THE CONSUMER MUST HAVE THE OPPORTUNITY TO INFLUENCE THE PRODUCER.

In nature, there are only two ways for the **CONSUMER** to influence the **PRODUCER**:

the first way of influence is the market, when the **CONSUMER** influences the **PRODUCER** by buying a better and cheaper product;

the second way of influence is direct, when the **CONSUMER** influences the **PRODUCER** by ordering from him what he wants, that is, products (goods, works, services) of a specific consumer value.

For example: when you stop a taxi and ask it to take you from point A to point B; when you order a tailored suit or a house built according to a specific plan, then in all of the above cases you are ordering a product of a specific consumer value. That is, you are ordering what you want to receive specifically.

The second, direct method of influence is precisely the method of influence of **CONSUMERS** on **PRODUCERS** in the fair socio-economic formation that follows capitalism.

Under the capitalist mode of production (in a market economy), in the case where the **PRODUCER** is a monopolist, the **CONSUMER** has no opportunity to influence him, and accordingly will not be able to influence either the price of the product or its quality. Therefore, there will be a degradation (of the capitalist mode) of production. Since the producer has no need to develop, but on the contrary, he can worsen the quality of the product and raise the price.

We had a similar situation in the USSR, when we were forced to buy what was on the shelves, without any opportunity to influence the Producers. The quality, range and consumer value of the goods produced. There was a dictate of the State Planning Committee (= a dictate of the Producers). The same as under capitalism, when the Producer is a monopolist.

MACROECONOMIC (DIALECTIC) FORMULA OF A FAIR (JUST) METHOD OF SOCIAL PRODUCTION:

CONSUMERS IN VIRTUE OF THE RIGHTS OF OWNERSHIP OF THE MEANS OF PRODUCTION, COORDINATE PRODUCERS, TO SATISFY THEIR NEEDS, THROUGH THE ORDERING OF THE GOODS, WORKS AND SERVICES BY MEANS OF A SPECIFIC USE VALUE AND THE REQUIRED QUANTITY .

The most effective economic relations are those in which the **CONSUMER** is the owner/employer of the **PRODUCER**. Then the goal of the **PRODUCER** is not to make a profit, but to fulfill the task-order of the Consumer in a timely and high-quality manner.

For example, if you are the **OWNER-CONSUMER** of an agro-industrial enterprise, then you will order (order) that you be supplied with environmentally friendly products, without GMOs and nitrates. Which is absolutely impossible to guarantee today, when **PRODUCERS** are concerned not with our health and longevity, but exclusively with profit.

Also, in the case we are considering, there are no intermediaries and advertising costs. All this will significantly reduce the cost of products. In practice, the above-mentioned formula and the formation as a whole will work as follows: each **PRODUCER** will be managed by an association (meeting) of its **CONSUMERS**, through a portfolio of orders that they will form for him.

The most important CONSUMER, inducing the entire process of orders, will be the population of the country, which will form portfolios of orders for the entire spectrum of its needs.

By virtue of ownership of the means of production, the population delegates to all PRODUCERS the right to manage their suppliers. In other words, when the PRODUCER acts as a CONSUMER, then he, through orders, will similarly manage his suppliers.

For the convenience of forming order portfolios and for managing enterprises of regional significance, it would be advisable for the population of the country to divide into regional consumer associations/societies. Which will be managed by the population of these regions, through orders placed by them for goods, works, services.

If we touch upon the functioning of enterprises in the non-production sphere of activity, the principle of their management will be the same. For example, the activities of the kindergarten administration will be controlled and coordinated by parents and representatives of the primary school, to whose jurisdiction the children will then be transferred. The activities of schools will be controlled and coordinated by representatives of universities, etc.

If we try to imagine the functioning of the future formation in existing economic forms, this can be done by imagining a situation in which all enterprises in the country are owned by one joint-stock company. Where each citizen has one share with the right to vote. And this share does not bring dividends, but gives the right to order (purchase) any product at cost.

As production is automated and robotized, the price of products will tend to zero. As a result, non-cash relations will come.

Progress will be ensured by fundamental science, research and industry institutes, design bureaus, moving from what has been achieved to something better. Focusing on the wishes and tasks of Consumers (based on the wishes and goals of the main Consumer - the population).

The power of the people will be realized by ordering the desired products from Manufacturers (including by ordering services from the administrations of territorial entities).

Control - through the consumption of ordered services, works, goods. If the population is dissatisfied with the work of any manufacturer (legal entity), then it will always be able to change its director, being the owner. Similarly, the association of CONSUMER enterprises, can change the director of the SUPPLIER enterprise.

In the coming economic formation, there will be practically no suppression of the desires of the minority, the desires of the majority. Since everyone will be able to independently determine the range of their needs (consumption).

The consumption process for individualists will look like this. A person approaches an industrial 3D printer, makes an order, presses a button and receives the product.

I hope I have explained clearly how the formation of the future will function and how the power of the people - the power of each one - will be realized in it. But in order for everyone to be able to approach a 3D printer, the printer, of course, must be Public Property.

On page 42 of this Doctrine (Axiom Eight), I wrote that the final phase of Absolute People's Power is the transition from political governance to economic governance.

In connection with this, I would like to explain that in this second final phase, the functions of territorial administrations will be supplemented by the function of providing their population with the necessary goods, works and services. Where territorial administrations will first form portfolios of orders from the population, and then place them at enterprises producing these goods, works and services. Acting as the owner/employer by virtue of the rights delegated to them by the population (District, City, Region). If an enterprise produces goods for the population of several territorial entities, then the customers form the Managing Association of Consumers of this enterprise, (similar to the Meeting of Shareholders), where everyone will have equal rights and the opportunity to place orders, according to the number of the population that they represent.

The Managing Association of Consumers, like all other structures, will be under the constant supervision of the Duty Representatives from the Population of the appropriate level.

CHAPTER 6

THE INFERIORITY AND THIEVISH NATURE OF CAPITALISM

Firstly, capitalism is a socially unjust system. Built on the exploitation of the population, that is, on the appropriation of the results of someone else's labor is theft. But stealing occurs not only in the production process, it also occurs in trade. For example, Chenghis Khan allowed merchants to make surcharge on goods in the amount of no more than 3%. Today there are no limits. Sellers, having entered into a cartel agreement, can set any prices. For example, the retail chains in Russia can buy cucumbers for 80 rubles and sell them for 300 rubles. Isn't this a robbery of the consumer (population)? Of course, the banking sector is warming his hands on everything that is happening, showing multibillion-dollar profits.

From the point of view of fair industrial relations, where the principle of paying «TO EACH ACCORDING TO WORK», the availability of profit is a **fact of stealing**. All religions consider theft to be mortal sin. Therefore, the world religions are obliged to declare capitalism a thievish, God-unpleasing system.

Secondly, capitalism today causes enormous, irreparable damage to the ecology and natural resources of the planet provoking unnecessary - excessive consumption and overproduction.

Defects are deliberately put into technical products, which after a certain time put them out of order. Significantly shortening their service life. On the contrary, preservatives are put into food products, significantly extending their shelf life (in the interests of trade). This already has a negative impact on the ecology of human health. The barbaric attitude towards the environment and people, motivated by the thirst for profit, can be seen in all directions.

Thirdly, the capitalist mode of production is flawed in principle.

I will give a clear example. The planet is full of idle production capacities, full of unemployed people willing to work. We, consumers, are always ready to consume more.

But the economic situation reaches a dead end and a crisis sets in. What is the problem?

The problem is that capitalists put **profit in first place**, and not **the satisfaction of our interests (needs) of consumers, which is primary**. That is, under capitalism, the secondary takes the place of the primary. If we put **the primary**, as it should be, **in first place**, we will get a perfect, crisis-free economy. **A golden age will come for humanity.**

Today, as a result of mergers and acquisitions by larger corporations, smaller ones, competition between manufacturers is becoming more and more conditional. A clear example of this is the automotive industry. Today, several well-known brands have one owner (for example, the Volkswagen Group).

The same thing is happening in the aircraft industry. The controlling stake in Boeing and Airbus is in the hands of the same people. Who, for example, by bankrupting Boeing, will ruin its shareholders, but will not suffer themselves. Since Boeing buyers will become Airbus buyers.

The sword of Damocles of capitalism today is a trillion-dollar money bubble formed on the stock markets (due to systemic crises), which, when burst, will devalue all cash and non-cash monetary units. The introduction of digital money will freeze this bubble, as well as all other savings.

CHAPTER 7

FASCISM - THE IDEOLOGY OF THE WORLD CAPITALIST ELITE

A turning point has come in modern history. The Golden Calf against humanity. In 1933, a similar project - fascism, was already implemented in Germany with the support of big capital. Our primary task is to prevent this from happening again.

Today in the world, as a result of capital accumulation, a polarization of wealth and power has formed between an insignificant group, on the one hand, and humanity on the other. This insignificant group considers itself the masters of the planet Earth, and humanity its own property, which has no right to vote and choice.

When it became obvious that the historical time of capitalism was ending, they (the super-rich) decided to stop evolution, destroy the majority of the population and preserve their power in the form of a dictatorship. Isn't this fascism in its worst form?

It turns out that the final phase of capitalism is not imperialism, but global fascism - fascism of the super-rich.

To date, the globalists have already violated the Nuremberg Code, more than once. For example, by organizing the vaccination of billions, with an experimental vaccine, having previously infected a significant part of the planet's population with COVID-19. Injustice, including social injustice, is evil. The owners of Money - the world's super-rich elite - are the embodiment of this evil.

Evil will not voluntarily go over to the side of good. Therefore, humanity should not hope for any humanity from the top of world capital. A monster, behind which there is a long bloody trail, only the civilian population destroyed by it. Remember the inhabitants of Hiroshima and Nagasaki, remember the women and children burned by napalm in Vietnam. Remember the millions of other innocent victims who suffered from their policy of reorganizing the world in their favor.

The use of depleted uranium ammunition by NATO troops, during the bombing of Yugoslavia and Libya, is this not an obvious military crime against humanity, like all their other crimes? The secret bacteriological/biological war against humanity began with the emergence of AIDS, which has already claimed millions of human lives and continues to infect the population of the planet to this day. Later, regular attacks of various pandemic flus began. Then, atypical pneumonia in China, during the 2008 Olympics. Ebola in Africa and coronavirus in South Korea with a very high fatality rate. The Zika virus, which became active in Brazil before the 2016 Summer Olympics. And since 2019, the next coronavirus, COVID-19, but already with a global geography, allowing interested parties to designate it as a pandemic. For further manipulations with vaccines and for the introduction of various restrictions.

There is no doubt that all previous attacks on humanity were organized by the world's super-rich elite - the Money Masters.

Because, apart from them, no one needs it, firstly.

Secondly, this is the declared program of the Bilderberg Club.

Humanity must know its murderers by sight. Unfortunately, despite the fact that all world wars and the listed crimes against humanity were organized by usurers-bankers (Masters of money), Western ordinary people are horrified by the word communism. Why? Because this is a consequence of many years of continuous bourgeois propaganda (intimidation), already at the genetic level, settled in the heads. Since lies are the main component of the ideology of any unjust society.

The ruling minority, in order to sit on the neck of the people carefree, needs the population to be ignorant and immoral. Ignorant, so that it is easy to manipulate them. Immoral, so that from its ranks it would be easy to recruit bastards who would shoot at the people, their own and any other, for 30 pieces of silver. To grow deadly viruses, to bear false witness, and so on.

Through the media, upbringing and education, the population is processed, praising and instilling the ideology of the cult of money, consumption, egoism and sodomy. With the goal of washing out of people's consciousness the very concept of justice, which is basic for all moral and ethical human principles. Unfortunately, the consciousness formed by capitalist existence orients its bearers not toward justice and common (social) problems, but exclusively toward personal gain. This is precisely what divides people, making them slaves of money, and accordingly slaves of the Masters of money.

Therefore, the globalists/Masters of Money do not even hide their satanic plans, knowing that all the thoughts of the population - adherents of the Golden Calf, are occupied with the topic of making money. That is, they are occupied with serving them - the super-rich, who are at the top of the food chain.

What is fascism? Fascism is the unification (bundle) of creatures, who deny humanism and compassion in principle. The fascism of today is the unification/fascism of the super-rich (not the nation), with the aim of preserving their dominance for centuries, by building a global digital concentration camp for humanity and the disposal of the "excess" population. They do not care about the fate of billions. They care only about their own skins. They are ready to dispose of everyone indiscriminately. Children and adults. As their predecessors did in the death camps.

Therefore, to rise up to fight global fascism, today is the duty and responsibility of everyone. No one has the right to stand aside.

Any public figure, any public figure, journalist, blogger, etc., who do not put the fight against global fascism at the forefront of their speeches/appeals, are its accomplices, as they lead the population away from solving the main problem of humanity today.

Today, globalists are boiling humanity like a frog, gradually raising the temperature - everything is according to plan.

Where is the first step, this is the rejection of cash.

The second is the transfer of non-cash money to digital, completely controlled by the administration of the digital concentration camp.

Thus, Putin has already publicly demanded the accelerated introduction of the digital ruble, and the governor of the Krasnodar Territory, the establishment of the Max messenger for the administration employees. Why? What, do we not have any other, more important problems? So that the construction of the global digital concentration camp goes according to plan.

For example, in Kyrgyzstan, payment for goods in stores began to be carried out only by bank transfer. This is what has already been done in many European countries, where the lion's share of all payments are made only through non-cash.

Ursula von der Leyen has already announced that the introduction of digital euros will begin in 2026. The United States and Russia have also announced that they will introduce digital dollars and digital rubles starting in 2026. But naive citizens do not attach much importance to this, believing that all this is done exclusively in their interests. That is, to fight corruption, which the media (to disorient the population) declared the main culprit of all the troubles and problems of today. When every reasonable person should understand that the real reason for all the troubles is that power on planet Earth is in the hands of parasites - 0.01% of the super-rich Owners of Money, who, through the appointed presidents, unleash wars in order **to create an image of the enemy of one nation, in person of another nation**, in order to distract humanity's attention from global reformatting – plunging the population into digital slavery.

The main task of any ruling minority is to maintain power over the majority, by any means. This is what we are witnessing today, the establishment of global fascism of the super-rich.

On weekends, on the streets of cities, you can see the public strolling carefree and young people making rosy plans. But almost all of them do not realize the irreversible threat hanging over humanity - to find themselves in a digital concentration camp at one moment, under total surveillance.

Which slave was considered the most dangerous in ancient times? A slave who is not engaged in labor. Because in his free time, he could start to think about the injustice of his position.
